INTRODUCTION

For decades, research has demonstrated that adverse childhood experiences (ACEs)—such as having an incarcerated parent or being exposed to a parental substance use disorder—can have profound, long-term impacts on a child's health, development, and future.

Since 2017, All Rise has partnered with Sesame Street in Communities (SSIC) to reduce trauma and promote resilience in justice-involved families. Together, we deliver trusted, evidence-based, educational tools to the front lines of the justice system—reaching judges, case managers, treatment providers, and the families they serve:

- Children have comfy, cozy spaces in courthouses that reduce trauma.
- Parents and caregivers are connected to family-centered resources to help them explain addiction, separation, and justice involvement in age-appropriate ways.
- Court and supervision staff are trained to support family resilience and healing across the justice process.

In 2024, All Rise expanded the program to offer specialized booster training focused on critical areas like parent/child communication, the importance of caring adults, reducing shame and stigma, and developmentally appropriate communication.

PROVEN IMPACT

All Rise and SSIC have worked with jurisdictions across the country to implement our unique approach, and pilot site results validate our methods:

- Significant knowledge gain: Participants reported a deeper understanding of how to support children and caregivers.
- High intent to implement: Participants plan to use Sesame materials widely—in courtrooms, offices, client meetings, and family sessions.
- Positive early outcomes: Surveys and interviews show that both court staff and caregivers are benefiting from the tools and training provided. A full evaluation is underway and is expected to be complete in early 2026.



WHAT WE KNOW

- Families navigating the justice system experience stigma, separation, and trauma.
- Caregivers often struggle to explain complex topics like addiction and the court process to their children.
- Judges and service providers are looking for trusted, familycentered tools that build resilience and improve outcomes.
